Personal Umbrella Overview

Highlights

- \$1/2/3/5 million liability limits available
- \$100/300/50 underlying auto limits available (drivers ages 22-69)
- Drivers under 22 acceptable with 1 incident
- MVRs or medical records not required with submission
- Classic, showroom and antique vehicles acceptable (Add \$25 per vehicle to premiums listed in the tables)
- New Special Tier accepts up to 10 vehicles and properties, up to 8 drivers, 3 accidents and 6 violations, 1 DUI and acreage up to 1280 (additional charges apply per added exposure)

Program Qualifications

- Maximum of 10 vehicles licensed for road use (owned, leased or regularly operated by the insured or a member of the household)
- Maximum of three watercraft (other than canoes, jet skis and wave-runners)
- Maximum of 8 drivers
- \$300,000 underlying homeowners limit required

Submissions

- Quote and submit applications via RLI Access Link in Arrowhead Exchange
- Mail original, signed application and annual premium payment to Arrowhead
- Make checks payable to RLI Insurance Company or Arrowhead General Insurance Agency, Inc.
- Completed application and payment must be received within 5 business days of the requested effective date
- Renewals can be paid by phone with a credit or debit card by calling RLI at 800.526.1754

Endorsements

- Changes to the following may be submitted midterm via mail or fax:
 - Insured name - Address
 - Add/delete UM/UIM coverages - Liability limits
- All other endorsements will be processed at renewal
